Execution of Activities in Compliance with the Legislation, Execution of Communication Activities, Execution / Supervision of Business Activities, Execution of Service Sales Processes, Execution of Contract Processes, Execution of Marketing Processes of Products / Services, Informing Authorized Persons, Institutions and Organizations, Execution of Management Activities, Execution of Finance and Accounting Affairs, Execution of Company / Product / Services Loyalty Processes, Execution of Assignment Processes, Follow-up and Execution of Legal Affairs, Receiving and Evaluation of Suggestions for the Improvement of Business Processes, Execution of Business Continuity Activities, Execution of Customer Relationship Management Processes, Execution of Storage and Archive Activities, Execution of Contract Processes, Follow-up of Requests / Complaints.

4. Legal Reason

5. Transfer of Your Personal Data to Third Persons in Turkey

Your personal data may be transferred to Authorized Public Institutions and Organizations and our Suppliers within the scope of the above-mentioned purposes and legal reasons.

6. Transfer of Your Personal Data to Third Persons Abroad.

Your personal data is not transferred abroad.

7. Retention Period of Your Personal Data

Your personal data is primarily stored for the periods determined in the legal legislation. If a storage period has not been determined in the legal legislation; we keep your personal data for as long as required by the purpose of processing. A period of 6 months to 1 year for the storage of your data, if any, depending on the purpose of processing, if any, for the storage of your data, by taking into

account the possibility that a request from a court or an administrative authority authorized by law regarding the relevant data reaches us late, or that a dispute that we may be a party to occurs. The storage period of the data is determined by adding the data, and at the end of the specified period, the said data is deleted.

8. Your Rights Regarding Your Personal Data

- Learning whether your personal data is processed or not,
- If your personal data has been processed, requesting information about it,
- To learn the purpose of processing your personal data and whether they are used in accordance with the purpose,
- Knowing the third parties to whom your personal data is transferred, in the country or abroad,
- Requesting correction of your personal data if it is incomplete or incorrectly processed,
- Requesting the deletion or destruction of your personal data within the scope of the conditions stipulated in the KVKK legislation,
- When you request the deletion or destruction of your personal data with the correction of incomplete or inaccurate data, requesting that this situation be notified to the third parties to whom we have transferred your personal data,
- If you suffer damage due to the illegal processing of personal data, you have the right to demand that this damage be remedied.
